

Terms of Service – Tests to Detect SARS-CoV-2 Coronavirus and the COVID-19 Corona virus

1. General

Welcome to the AID Genomics website, which is managed and operated by AID Genomics Ltd. ("AID"), to the Department for the Coordination of Testing Services for the Detection and Identification of the Presence of the Corona COVID-19 virus (hereinafter: "the Site", "the Service" or "Test" and "Corona", respectively).

Access to and use of the Site, including use of the Service is subject to the terms of use set forth below (the "Terms of Use"), and therefore you are requested to read the Terms of Use carefully. The registration for the use of the site or the actual use of it indicates your consent to the terms of use. The terms of use are worded in male language for convenience only, and they also apply to female language. Also, every time an individual is addressed, it also means the plural, and vice versa. AID reserves the right to change the Terms of Use at any time, in its sole discretion.

2. About the Site

2.1. It is clarified that AID may change (including expand or reduce) the service characteristics provided on the site, at its sole discretion and without giving any notice thereof.

2.2. Any person may use the site for the sole purpose of obtaining information. Any use that exceeds the mere receipt of information, including the purchase of the service, may only be performed by those who meet the following cumulative conditions: (a) he is an adult legally capable of executing legally binding actions, and if you are a minor or you are not legally allowed to perform legal actions without your custodian or a guardian, your use of the site will be deemed to have been done after receiving approval, and (b) the user is registered as a user of the Site, as required - as set forth in Section 3 below.

3.2. []]. You are responsible for all actions taken or will be done within the site under your username, and you must keep your account information secure. AID will not be liable for any damage or loss caused by any unauthorized use of your account.

3.3. It is emphasized that the data you provide will be stored in an AID-owned database only for the time required and reasonable for the purposes for which it was collected, at AID's sole discretion, or until we receive an express request for deletion, and in any case - as required by law. You acknowledge that you are aware that there is no legal obligation to provide the above data, and their delivery is subject to your will and consent, and is subject to the site's privacy policy available at: [- if at the time of publishing these Terms of Use no separate privacy policy exists - we will update the terms of use accordingly] ("Privacy Policy").

4. The Service

4.1. AID provides the service to the users of the site (hereinafter: "the Customer of the Service") through (a) prior coordination of [arrival at AID laboratories] [] or AID's sampling points at various sites around the country, (b) prior coordination of arrival a human sampler to the residence of the Service Customer, at the choice of the Service Customer.

4.2. AID also operates via representatives, suppliers and subcontractors and any reference in the site to AID may also refer to and / or only to such representatives, suppliers, and subcontractors.

4.3. The tests in the service are conducted using samplers who are authorized to do so, using the most advanced sampling kits and safeguards approved by the Ministry of Health. [The company works with a certified laboratory authorized by the Ministry of Health to perform Corona tests and with [Rescue Union Organization] [Magen David Adom]].

4.4. The test as part of the service is performed by taking a sample from the oral cavity and nasal nostrils of the specific sampled person (hereinafter: "the Tested Person") using an applicator (a stick with a cotton swab on it) (RT-PCR). After performing the aforementioned sampling, the applicator will be sent for molecular testing in a virus laboratory, through which the unique genome (genetic structure) of the corona is identified. At the time of the examination, the Tested Person will sign a consent form and a waiver of confidentiality in the format that appears in the link below: [Job note: to be completed].

4.5. The Customer of the Service will select on the website [and / or through the service center] the time slot requested by him to perform the test according to the available time slots that will be displayed on the website [and / or offered to him by telephone by AID representatives] ("the Time Slot"). [The customer of the service may change the Time Slot via the website and / or the service center, provided that the Time Slot is changed no later than fourteen (14) days from the date of ordering the service and at least two working days in advance, before the Time Slot] [

4.6. It is the responsibility of the customer to be at home and / or at the business, at the address provided by him when ordering the service ("Customer Address") for the entire slot of time. [In the event that the service customer has ordered the service for additional family members and / or for a group of employees and / or any other subject, it is the responsibility of the Service Customer to ensure the presence of all the subjects at the Customer's Address during the time slot. In the event that a test ordered was not performed due to the absence of the Service Customer and / or was tested on his behalf at the Customer's Address during the time slot, the payment for the test that was not performed will not be refunded]

4.7. It is the responsibility of the Service Customer, and as the service customer orders the service for additional tested persons, it is the responsibility of the Service Customer also in relation to the additional tested persons (including, but not only, a Service Customer and / or a tested person leaving the country who is required to present corona test results) to type the details as they appear in the passport (spelling of name and passport number) of the Service Customer and / or the Tested Person. The name that will

appear on the test results is the name entered when ordering the appointment, and the responsibility for typing it rests solely with the Service Customer.

4.8. At the time of the test as part of the service, the Tested Person will present a certified ID to the certified sampler person and the Tested Person will sign a medical questionnaire, in the format that appears in the link below: [].

4.9. In accordance with the reporting obligation under the provisions of Regulations 65 and 66 of the Public Health (Medical Laboratories) Regulations, 1977, in the event of a positive result or suspicion of a positive result for SARS-CoV-2, AID will submit a report to the head of public health services at the Ministry of Health and / Or his deputy and / or the director of the Central Virus Laboratory and / or any other body or entity in accordance with the law.

4.10. It is clarified that AID may make use of the information and share the information received by the Service Customer and / or the Tested Person as part of the use of the website and / or receipt of the service, including in relation to the test results within the service, as required by law.

4.11. AID does not undertake to adjust the service in general, and the test result in particular, both during the time slot and at any time thereafter, for any particular purpose or target.

4.12 Receipt of the test results will be received by the Service Customer [by e-mail and / or text message to the mobile phone] [within [__] hours from the date of the actual test.

4.13 There may be delays in delivering test results in accordance with the workload at the laboratories and as per national needs as determined by the Ministry of Health from time to time.

4.14. It is the user's responsibility to make sure that the time slot and schedules for testing and receiving the said results suit his or her needs.

4.15. It is clarified that different variables may lead to tests for coronavirus detection leading to results that are not fully accurate, for example when the test is taken at a very early stage of infection / exposure to coronavirus. Therefore, AID does not warrant that the test results are fully accurate. It is possible that in some cases the corona test should be performed several times, thus reducing the probability of inaccurate results.

5. Purchasing the Service

5.1. AID allows the users of the site to purchase the service offered at the site by paying the amounts listed next to each service, and subject to the terms of employment which are indicated next to each service (the "Transaction"). All amounts listed on the website include VAT unless expressly stated otherwise.

5.2. AID may from time to time update the terms of the Transaction that are specified next to each service on the site, add or remove details, remove products that are out of stock and also update and / or change the price of the service from time to time.

5.3. You can pay with a valid credit card that can be cleared via any of the credit card companies that operate legally in Israel.
